- ➤ Alfred University Flags are all sold. 24 were sold in less then a year. Official logo is not on the flags. Decided to order 24 regular size flags and Chris Robinson will check the price of athletic size flags. Council will sell and raffle flags at the Homecoming football game.
- ➤ Rings are still being sold. Since 2005 196 rings have been sold and Council has received \$8 thousand of which the Alumni Council owes Bookstore \$690. The ring company owes the Bookstore \$45 and the Council \$30.
- ➤ Treasurer's Report: Income \$1,725 Expenses \$939, net income \$1,208. Checking account balance is \$6,138 and the Treasurer was authorized to pay the Bookstore the \$690 that is owed.
- ➤ Discussed continuing to use Basecamp. Brad paid the \$20 a month fee himself. It was decided to use Google Docs instead and Elizabeth is going to create the Google Docs account.
