# Constitution of the Young Women's Christian Association of Alfred University

# ARTICLE I-NAME

This organization shall be called the Young Women's Christian Association of Alfred University.

# ARTICLE II-PURPOSE

The Young Women's Christian Associaation of Alfred University affirming the Christian faith in God, the Father; and in Jesus Christ His only Son, onr Lord and Saviour; and in the Holy Spirit, the Revealer of Truth and source of power for life and service; according to the teaching of the Holy Scripture and the witness of the Church, declares its purpose to be:

- 1. To lead students to faith in God through Jesus Christ;
- 2. To lead them into membership and service in the Christian Church;
- 3. To promote their growth in Christian faith and character, especially through the study of the Bible;

4. To influence them to devote themselves in united effort with all Christians to making the will of Christ effective in human society, and to extending the Kingdom of God throughout the world.

### ARTICLE III-MEMBERSHIP

Sec. 1. Any woman of the institution may be a member of the Association provided:

a. That she is in sympathy with the purpose of the Association.

b. That she makes the following declaration: "It is my purpose to live as a true follower of the Lord Jesus Christ."

Sec. 2. Qualifications for Leadership:

a. All members of the Cabinet (officers and chairmen of standing committees) shall commit themselves to furthering the purpose of the Association.

b. Two-thirds of the cabinet members shall be members of churches which are entitled to representation in the Federal Council of the Churches of Christ in America, and only those delegates who are members of such churches shall be entitled to vote in conventions.

c. Members of the Advisory Board shall meet the qualifications of cabinet members.

Sec. 3. A field or headquarters student secretary shall be eligible to membership in the Association.

Sec. 4. Any woman who is in sympathy with the purpose of the Association and who contributes to the life of the Association may be elected to honorary membership in the Association.

- Sec. 5. Every member of the Association shall be expected to participate in and share in the direction of the Association but only students shall be eligible to hold office.
- Sec. 6. The regular membership dues shall be \$1.00 per annum and the Association shall secure funds needed to carry the annual budget in some method such as voluntary contributions from students, faculty, and alumnae, and any others interested in the work and purposes of the Association.
- Sec. 7. A member may be received from or transferred to any other local Association affiliated with the Young Women's Christian Associations of the United States of America which makes provision for such transfer. Such transfer must be in accordance with the membership basis of the receiving Association, and shall be considered valid until the expiration of the original membership.
- Sec. 8. There may be received by transfer any woman who is a member of any other student movement which is affiliated with the World Student Christian Federation.

# ARTICLE IV-OFFICERS

Sec. 1. The officers of the Association shall consist in the office of President, Vice-President, Under-graduate Field Representative, Secretary and Treasurer. They shall be chosen by ballot at the annual meeting of the Association on the first Sun-

- day in March, at which meeting an annual report of the President, Secretary and Treasurer shall be given. These officers shall enter upon their duties the first week in April having met with the old cabinet at all meetings since their election.
- Sec. 2. The President shall preside at all business meetings of the Association. She shall appoint the chairmen of all committees. She shall see that the committees are instructed in their work as soon as possible after appointment. She shall hold all committee chairmen responsible for the work of their respective committees, and endeavor to develop a staff of workers for future service. On retiring from office she shall present a written report covering her term of service, with recommendations concerning the future work of the Association.
- Sec. 3. The Undergraduate Representative shall have charge of the general correspondence of the Association, and keep in communication with the territorial or state committee and the National Board of the Young Women's Christian Association of the United States of America.
- Sec. 4. The Vice-President shall share the duties of the President and in the absence of the latter, shall perform her duties.
- Sec. 5. The Secretary shall keep full minutes of all business meetings of the Association and of the Cabinet. She shall notify all members and officers of their election and assist the president in the

general correspondence of the Association. She shall keep a statistical register of all the work done by the Association, including the number and character of meeting held under its direction, the attendance and results, membership, work of committees, etc.

Sec. 6. The Treasurer shall have charge of the funds of the Association under the direction of the Cabinet, and shall keep an account of all receipts and disbursements and render a written report monthly. She shall act as a member of the finance committee.

Sec. 7. If any vacancy occurs in the offices, it shall be filled by ballot at the next meeting of the Association or at a special meeting called for that purpose,

# ARTICLE V-COMMITTEES

Sec. 1. Immediately after the election of the president, the following standing committees shall be appointed:

(1) The Social Committee which shall include social standards and social service. Throughout the year it shall plan a social life for the Association, the aim of which shall be to unite all young women in the Association in a Christian fellowship.

(2) The Conference Committee, which shall also act as the Finance Committee. It shall have charge of matters relating to the Conferences and Conventions of the Young Women's Christian Association and of the Student Volunteer Movement. It shall endeavor to create interest and secure funds for delegations to these conferences.

- (3) The Publicity and World Fellowship Committee which shall see that notice of all Association activities is given to the college body, and that the Association is kept in touch with the activities of the Young Women's Christian Association in foreign countries.
- (4) The Prayer Meeting Committee which shall also act as the Program Committee. It shall provide for regular devotional meetings of the Association, appoint leaders and suggest topics.
- (5) A Freshmen commission which will be composed of a chairman and four other freshmen appointed by the President. It will aid the cabinet members in general and have charge of all rooms used by the Association.
- Sec. 2. Two weeks previous to the election the president shall appoint a nominating committee.
- Sec. 3. Special committees for other purposes may be provided and their work defined by vote of the cabinet. They shall be appointed by the president.

Sec. 4. The president shall be a member ex-officio of all committees.

Sec. 5. A full Cabinet meeting including all the cabinet members and members of all committees shall be held once every month, when the work of each committee shall be discussed.

Sec. 6. The five officers together with the chairmen of all standing committees shall constitute the cabinet of the Association and shall have general management of the affairs of the Association. The Cabinet shall meet once a week and at the call of the president if necessary.

#### ARTICLE VI-MEETINGS

Business meetings of the Association shall be held at stated intervals for the transaction of necessary business of the Association. The annual meeting shall occur the first Sunday in March.

#### ARTICLE VII-AMENDMENTS

Sec. 1. Procedure. Notice of proposed amendments to this constitution shall be given at the previous regular meeting and shall require for their adoption a two-thirds vote (affirmative) of the members present, except this Article and Article III, and Article III, Sections 1 and 2, which shall not be altered or repealed except by the two-thirds vote of the Association for two consecutive years at its annual meeting.

Sec. 2. Affiliation Affected. Should Article II or Article III, Sections 1 and 2 be altered or repealed and any membership basis adopted other than the authorized alternate basis, that is the Church Membership basis, the Association would forfelt its right to membership in the National Young Women's Christian Associations of the United States of America, according to the constitution of the National Organization, and would thereby also forfeit its affiliation with the World's Student Christian Federation.

#### **FACULTY RULES**

# Assembly

On Wednesday at 11:15 o'clock there is a general College Assembly before which one of the instructors presents a prepared address. One-half a semester hour credit will be allowed for attendance at Assembly. provided absences do not exceed three for the semester.

# Student Advisers

Each student on entering college will be assigned to some member of the Faculty who will act as his adviser until May 1 of the student's sophomore year. At that time the adviser will report to the faculty the student's choice of major and minor. The professor who has charge of the student's major work will then be his adviser.

# Registration Rules

Students will register at the Registrar's office on registration days. A fee of two dollars will be charged for late registration.

Students are expected to register for no more than 17 hours, but if a student has an average standing of B in the preceding semester he may register for 18 or more hours upon the approval of the Dean and Registrar.

Physical Training and Assembly may be taken in addition to the maximum of 17 hours.

Regulation concerning standings to be maintained by students to entitle them to the privilege of registration the following semester:

Freshmen are required to have an average scholarship index of 0.

Sophomores are required to have an average scholarship index of 0.15.

Juniors are required to have an average scholarship index of 0.25.

Seniors are required to have an average scholarship index of 0.30.

For graduation it is required that a student have an average scholarship index throughout his course of 1.

Scholarship indices are explained on page 20 in the catalogue.

Students desiring to drop a subject for which they have registered must obtain permission of the instructor and report to the Registrar's office. If however, a subject is dropped after the first two weeks of a semester it is reckoned as a failure.

# Standings

The standings of students are reported to them only by letters, and not by percentages. A signifies 90 per cent and above; B, 80 per cent to 90 per cent; C. 70 per cent to 80 per cent; D, 60 to 70 per cent; E, conditioned failure; F, failure.

D is reckoned as a passing mark; but for graduation it is required that a student have a scholarship index of 1.00. The major work must have an average grade of B, or a scholarship index of 2.

No credit is given, except by special vote of the Faculty for one semester of any course which the instructor has designated to be pursued for a full year. A "condition" or E grade shall be given whenever a student has failed to do work of a passing grade, but has done sufficient work to be able to complete the course with out repeating the class work. A condition may be removed any time during the following semester. Upon report from the instructor that the condition has been removed the office will change the grade from E to D.

An incomplete (designated by the letters "Inc") shall be given to the student whose work has been of passing grade but who has not completed the full amount of work required by the end of the semester. An incomplete may be removed during the following semester, when the student has satisfactorily completed the required work. In the semester in which the incomplete is being removed the student shall register for the same and shall pay with his tuition an "incomplete fee" of \$1.00 per hour credit to be obtained for the course.

When a student has failed to complete one-half of the work required in a course, the final grade will be F and not "Inc."

An incomplete or a condition which is not removed during the next following semester of residence in the college shall automatically be changed in the office to a failure (F) grade.

# Examinations

Final examinations are held at the close of each semester, and sometime near the middle of each semester mid-semester examinations are given. Occasionally written tests are held during the semester. Fees will be charged for all examinations taken by those not regular members of classes or for examinations or announced hour class tests taken at other times than those appointed. The fee for a special examination to take the place of a final examination or a mid-semester examination is \$5. The fee for any special test to take the place of an announced one-hour class test is \$1.

When the student wishes to take a special examination or class test, he shall bring to the instructor a receipt from the University Treasurer, saying that the fee for the special examination or test has been paid. This receipt must be countersigned by the Dean (or by the Registrar in the absence of the Dean) to show that permission has been obtained to take the special examination. No special examination will be given by an instructor unless this receipt, properly countersigned, bas first been presented.

Seniors whose semester standing during the second semester is A or not less than B in any subject shall be exempt from final examinations in that subject.

# Absences and Excuses

Application for excuse for necessary tardiness must be made to the instructor in the course in which the tardy mark is received. Two unexcused tardinesses count as one unexcused absence.

- It is expected that no student will be absent from any college class except in cases of necessity. Necessary absences may, however, be allowed under the following regulations:
- 1. The Dean of the college and two members of the college Faculty, one of whom shall be a woman, shall constitute a committee known as the Committee on Absences, to whom application for excuse must be made.
- 2. At the end of each week each instructor shall report on the proper blanks to the committee all absences from class with a statement of cause, if known.
- 3. Applications for excuse must be made by the student in writing upon blanks provided for the purpose and must be presented to the committee within two days after the expiration of the absence. The excuse, if granted, is sent to the proper instructor by the committee; if not granted, it is returned to the student.
- 4. The committee will consider two kinds of applications for excuse: First, ordinarily reasonable excuses, if the number previously granted does not exceed the number of recitation periods per week; second, excuses in excess of this number for serious illness or other exceptional cause only. All excuses are granted with the understanding that any work missed will be made up to the satisfaction of the instructor.
- 5. All cases of student liness must be reported in person or by proxy or by telephone within tweve hours of the appearance of such illness, either to the Dean

or to the college medical officer, Dr. Russell Ferguson.

Only such applications for excuse for illness as are validated by the college physician will be granted. For the purposes of validation of such applications the services of the medical officer will be without charge to the student.

Any student ill of a contagious or of an infectious disease who does not report within the twelve-hour period will be subject to college discipline.

6. At the end of every semester the instructor reports the students' scholastic attainment in letters to the office. For unexcused absences in any course the instructor observes the following table:

- 7. When the number of unexcused absences in any one course equals the number of recitations per week, the committee shall notify the delinquent student.
- 8. Managers of student organizations and athletic teams, previous to their absence from college, must file with the committee a list of the members of the organization or team, with a statement of time the team expects to be absent. Such list is for the information of the committee and is not in lieu of any excuse or application therefor.

# Social Regulations

There is a college Committee on Student Life which has advisory supervision of activities in which the interests of the students in general are involved. This committee is guided in its action by the following general regulations concerning:

- (A) Committee on Student Life.
- 1. It shall be the duty of this Committee to supervise student life in dormitories. This shall be understood to include the right to make suggestions at all times to the matron of the Ladies Hall and the housekeeper at Burdick Hall, who shall be under their supervision, as to the administration of their respective houses.
- 2. The Committee shall have complete supervision over the boarding and rooming places of all college students both within and without the dormitories.
- 3. The Committee shall have supervision over all student social functions and amusements. Students desiring to promulgate

any entertainment, party, class affair, dance, etc., (this to include the so-called vacation dances), shal first make application to the Student Senate as provided in the student constitution. All permissions so granted shall be submitted to this committee for approval.

4. The Committee shall be a regular medium of intercourse between students and Faculty. It shall be its duty and privilege at all times to advise with the Student Senate and make suggestions to them bearing on matters of student conduct and self-government. The Senate is invited to confer with this Committee on any or all matters of student interest.

5. It shall be the duty of the Committee to hold itself in readlness to advise individually with students concerning their social and personal problems. One member of the Committee, a woman, shall act as adviser of women.

# (B) Dancing.

- 1. That there shall be no dancing together of men and women in any University building, except Alumni Hall and then only when approved by the Student Life Committee.
- That upon request from parent or guardian a student will be prohibited from dancing.
- 3. That all dancing shall be subject to the supervision of the Committee on Student Life.
- 4. Seniors may obtain permission from the Dean of Women for properly chaper-

oned parties to attend private out-of-town dances if the organization of such dances is such as can be approved by the Committee on Student Life. These privileges shall be accorded only to seniors who have approved themselves by their previous conduct in college.

# (C) Rooming.

- 1. A register of proper accommodations for students is maintained and supervised by the Committee on Student Life.
- 2. Men and women shall not room in the same building except with approval of the Committee on Student Life.
- 3. Young ladies shall be expected to engage rooms and board at the Ladies Hall unless they can show cause to the contrary.
- 4. Young women may not call at Burdick Hall or at any of the men's club houses or meet young men at the houses where they room. Young men and young women are absolutely forbidden to go to each others' rooms for any purpose, except by special permission which may be granted to brothers and sisters.

# (D) Chaperonage.

1. All evening picnics and automobile rides and all evening out-of-town parties, or groups of more than eight, of which men and women together form a part, must be arranged for beforehand with the Committee or Student Life, and provision made for proper chaperonage. This regulation applies to all college students except seniors.

- 2. Permission and chaperonage for seniors attending events lasting later than closing hours are to be arranged with the Dean of Women.
- (E) The above social regulations hold for holidays, Christmas, Thanksgiving, and laster vacations and Commencement Week and also apply to the day before the beginning of any semester and after the close of the semester.

# (F) Student Activities.

- 1. That the Faculty put itself on record as being in hearty sympathy with the regulation of the Student Senate that no social event or evening entertainment be permitted in the week preceding semester examinations and that none, except the Interscholastic dance, be permitted during the week of the Interscholastic Meet.
- 2. That no student be allowed to participate in dramatics—except in credit courses in the drama, in instrumental or intercollegiate athletic contests, to be on the staff of the Fiat or of the Kanakadea, to be a member of the Glee Club. or to hold an executive office in any organization connected with the University, who has not achieved or does not attain an index of 5.
- 3. That no other than University and college dances be given on the calendar of university events.
- 4. That students be allowed to hold office and participate in student activities only to the extent of the numerical value of their respective indices as classi-

fied and set forth in the accompanying schedule. (See scale for student activities published in the Student Senate Constitution.)

# Library Regulations

- 1. Books may be retained three weeks with the privilege of renewal except in cases of books for which there is frequent call.
- 2. A fine of one cent a day, Saturdays, Sundays, and holidays included, will be imposed for all books over due.
- 3. Books are transferable on cards at the desk. Borrowers are not expected to pass books from one to the other and in the event of loss by such practice the original borrower will be held responsible for the value of the book, the amount being determined by the Librarian.
- 4. Any person abusing the privileges of the library or violating its regulations will be subject to suspension from library privileges at the discretion of the Librarian.

#### Athletics

1. All students unless excused by the Director of Physical Training on the advice of a physician, are required to do one hour in physical training each semester during the freshman and sophomore years, under the supervision of the Director. The required work of the freshman year shall include lectures and gymnasium practice. Sophomores shall elect either advanced gymnasium practice or athletic sports supervised by the department of physical training.

- (I) Eligibility regulations.
- 1. In order to be eligible to athletic teams a student must take ten hours of work in College or fifteen hours in the Agricultural School.
- 2. If any student playing on an athletic team shall fall below a passing grade, the instructor shall notify the chairman of the athletic committee of the same before the beginning of the following week. In case the student shall be reported in two or more subjects he shall not participate in any athletic contest until the instructor shall have notified the chairman of the committee that the student has attained such grade. When the student is deficient in only one subject, he may be allowed four weeks from the time that he is reported to tring his work up to the passing grade before being debarred from the team. structors shall notify the committee of the removal of such condition as soon as possible.
- 3. No member of the faculty of Alfred University shall participate in any intercollegiate or inter-scholastic contest.
- 4. The second team shall consist of only those men who have regularly participated in practice against the varsity. The second team shall be under the jurisdiction of the coach, and no group of men other than the above stated shall represent the University in any form of athletics.
  - (II) General Regulations.
- The coach shall have complete jurisdiction of the team in all matters of conduct. He shall be required to suspend

- from the team for a time commensurate with the offense, any person gullty of immoral, ungentlemanly or unsportsmanlike conduct.
- 2. Each manager of an athletic team on the Monday previous to an out-of-town game must file with the Committee on Absences of the College and with the Director of the Agricultural School a list of the members of the team he intends to take, and also a statement of the time the team must be absent; and in case any one player will not receive excuses for his absences from classes the Committee or the Director will give the person notice to that effect.
- 3. No body of students exceeding four in number (two in basket ball) shall take part in any games played out of town, outside of the regular schedule approved by the athletic committee.
- Match games shall not be played on either Saturday or Sunday except by special permission of the President.
- 5. No more than one game of basketball, baseball or football shall be played in any one week, except when the team can profitably play a series of games on any one trip away from home. Extra games may be played on days when classes are not in session. (See rules 2 and 3).
- 6. The Faculty permits the following teams to make a schedule:—football team, women's basketball team, men's basketball team, track team, tennis team, cross country team, and wrestling team, also the corresponding second teams.
- 7. Second teams shall not play out-of-town games.

# Constitution of The Students' Association of The College Department of Alfred University

#### ARTICLE I-NAME

The name of this organization shall be the Students' Association of the College Department of Alfred University.

#### ARTICLE II-PURPOSE

Realizing that the faculty have supreme authority over all matters connected with student life and yet knowing that they are willing to co-operate with the students to promote the welfare of the school, the students have organized themselves into the Students' Association of Alfred University in order to develop a wise and intelligent self-control, to preserve and regulate beneficial customs and traditions of Alfred, to have charge of and control all college elections and to assume, whenever expedient, the control of student affairs, all subject to the further provision of this constitution.

#### ARTICLE III-MEMBERSHIP

Section 1. All persons enrolled as students in the College of Liberal Arts and in the New York State School of Ceramics of Alfred University shall be considered members of this Association.

Section 2. No tax shall be levied for the support of this organization except as may be voted by the Association for any purpose that the Association may deem necessary. Section 1. The Student Association shall be headed and represented by a Senate consisting of five members, three from the Senior class and two from the Junior class. There shall be in addition to these one consulting member from each of the lower classes and also the President of the Sigma Alpha Gamma who shall have no vote.

Section 2. The Senate shall have a President, Vice President, Secretary and Treasurer, and such other officers as it may deem necessary. The President, Vice President, and Secretary and Treasurer shall also act as officers of the Students' Association.

Section 3. The Student Body of Alfred University establish the principle of official responsibility for the actions of any class upon occasions of class functions. In the event of the class officers being unable to cope with a situation, they shall report to the President of the Student Senate or any member thereof, who shall take immediate action regarding the situation. If no member of the Student Senate can be found, the officers then shall report to an executive member of the University, such as the President or the Dean.

#### ARTICLE V-ELECTIONS

Section 1. On the first Wednesday in May of each year the Junior and Sophomore classes shall meet and nominate candidates for the Student Senate.

Section 2. Each class shall place in nomination twice as many candidates as it is entitled to members on the Senate for the following year, namely, six for the Junior class and four for the Sophomore class. Nominations shall be made verbally and voted upon by written vote. Each class shall place in nomination that number or more to which it is entitled. Each person must vote for the number of nominees to which his class is entitled, namely six for the Juniors and four for the Sophomores. A list of the nominations shall be placed on the bulletin board immediately after the nominations are made.

Section 3. On the following Wednesday the election shall take place in a meeting of the Student body. This meeting shall be presided over by the President of the Senate. He shall appoint tellers to take and count ballots.

Section 4. Elections for each class shall be held separately. Ballots shall be provided for each with the names of the candidates written thereon. Each student is entitled to vote for as many candidates as there are members to be elected from each class, which is done by marking off the names of those for whom they do not wish to vote.

Section 5. The three candidates in the Junior class and the two in the Sophomore class having the largest number of votes respectively, providing each has a majority of all the votes cast, shall be declared elected.

Section 6. In case the required number of candidates do not receive a majority of all the votes cast, balloting shall continue until an election is made, the lowest being eliminated at each ballot.

Section 7. The Freshman class shall elect its consulting member some convenient time prior to May 25th of each year.

Section 8. The incoming class of the following year shall elect its consulting member some convenient time prior to October 1st.

Section 9. The President shall be elected on the Wednesday following the election of the Senators at a joint meeting of the retiring Senate and the newly elected Senate, presided over by the retiring President.

Section 10. The new Senate shall complete its own organization.

Section 11. A vacancy on the Senate shall be filled by the election by the student body of one of two persons nominated by the class lacking the senator or representative.

# ARTICLE VI-ELIGIBILITY

Section 1. The President of the Senate shall be a Senior and he shall have served on the Senate either as a representative or as a senator prior to his Senior year, provided individuals so qualified have been elected to positions in the Senate, unless another Senator shall he elected by a two-thirds vote.

Section 2. Members of the Senate shall be eligible for re-election.

Section 3. No member or representative of the Senate shall lose his seat on account of a change in his college ranking.

Section 4. Three consecutive unexcused absences from meetings by any member shall terminate his membership. Excuses shall be presented to the Senate for acceptance or rejection.

Section 5. Any member is liable to impeachment for misconduct in office by a two-thirds vote of the Senate and can be removed from office by a two-thirds vote of the entire Students' Association.

# ARTICLE VII-MEETINGS OF THE SENATE

Section 1. The Senate shall hold regular meetings each week at a time set by the Senate at the beginning of each year. All of the regular business must be performed at this time.

Section 2. Special meetings may be called by the President at any time.

Section 3. Three members shall constitute a quorum in these meetings provided both Junior and Senior classes are represented.

#### ARTICLE VIII-POWERS

Section 1. The president shall preside at all meetings of the Senate, of the Association, and of the Student body.

Section 2. The Secretary and Treasurer shall keep the minutes of all meet-

ings of the Senate, of the Association and of all College Mass Meetings; he shall attend to the correspondence of the Association and perform such other duties as are usually performed by the Secretary of such an organization. He shall also have charge of such funds as are voted by the Association.

Section 2a. It shall be the duty of the Secretary to report all dates placed on the Calendar to the college office as soon as possible.

Section 3. The Senate shall have authority over all college customs and traditions; it shall organize and conduct all college Mass Meetings; it shall regulate and supervise student activities as stated in the constitution and regulations of student activities; it shall have complete charge of all student elections, except such as are incorporated in the other constitutions; it shall represent the Association in all its relations with the Faculty, Alumni, Trustees and other exterior bodies; it shall be authorized to use discretionary power in all matters requiring immediate action.

Section 4. The Student Senate shall have power to take cognizance of violation of the Campus Rules and shall be a Court of Last Resort lu the interpretation of these rules as provided in the Campus Rules.

Section 5. The Senate shall deal with all cases involving violations of the Honor System as stated in the Honor System Constitution.

Section 6. It shall be the duty of the Senate to condemn any practice which may be deemed not in accord with the true college spirit; to summon to its meetings individuals indulging in such practice or violating Campus Rules, and in case of proven misconduct, to inflict penalties which it shall deem expedient.

Section 7. In all cases its power may extend to public censure of individuals or groups of individuals for misconduct.

Section 8. The Student Senate, either on its own initiative or upon the suggestion of college officers, shall assume a vigorous control of situations arising in the field of student activities and student government for the purpose of preventing excesses and improprieties.

#### ARTICLE IX-MUETINGS

Section 1. All meetings of the Association, called for the purpose of elections and amending and revising the Constitution and By-Laws, shall be called by the President through a notice in the issue of the Fiat Lux preceding the meeting. All items to be considered shall be included in the announcement of the meeting.

Section 2. Special meetings may be held at the call of the President.

Section 3. Two-thirds of the student body shall constitute a quorum at these meetings.

# ARTICLE X-AMENDMENTS

Section 1. This Constitution and By-Laws may be amended at any regular meeting, provided such amendments have been read before the Student body; and published in the Flat Lux one week ahead; and have been passed by a two-thirds vote of those present.

Section 2. The Athletic Association Constitution, the Women's Student Government Constitution, the Honor System Constitution may be amended as stated in the different Articles under their respective Constitutions.

Section 3. The Junior and Sophomore classes shall each elect three members from a list of six recommended by the Student Senate and those elected, with a Junior member of the Senate as Chairman, shall act as a committee for the purpose of amending or supplementing these rules. Such measures as they adopt shall become part of said rules when adopted by the association.

Section 4. This Constitution shall go into effect upon its ratification by the Student Body.

# CAMPUS RULES

1922 - 1923

# ARTICLE I

The Campus Rules shall be incorporated into the By-Laws of the Constitution of the Students' Association of the College Department of Alfred University.

#### ARTICLE II

1. All Freshmen are required to wear either a green cap with a short visor and a large gold button or a green toque with a short tassel through the period covering the first semester of the College year, and in the second semester until April 1st, and for all college track meets and the Interscholastic Track Meet. Freshmen entering College the second semester shall wear the cap until April 1st. Moving up day shall be set by the freshmen with the approval of the Student Senate.

These caps are to be worn conspicuously upon the head every day in the week including half holidays, the exceptions being from sundown Friday night until Monday morning, vacations, and when the student is out of town. Freshman girls may discard their caps for special evening entertainments with the permission of the Student Senate.

First year Specials shall wear the same cap without the gold button and the same toque without the tassel. All the Campus Rules shall apply to first year Specials as to Freshmen. Any Special who has done work in another College shall not be subject to these Rules in regard to Freshmen.

- Freshmen are prohibited from wearing prep. school emblems, and monograms of any athletic association except that of Alfred.
- 3. Freshmen are prohibited from smoking in public, and all University students including students of N. Y. S. A. and A. H. S. from smoking on the campus, as herein defined: that portion of land within the following boundaries: Kanakadea Creek, Pine Street extended, the fence above the Steinheim and pumping house, and a line which will be a continuation of Ford St., to meet the other two boundaries. In addition to this shall be included the Park, Library Square, the Tennis Court and the Athletic Field. At the beginning of each school year a map of the campus shall be posted in some public place.
- 4. All freshmen and freshmen specials shall report for duty when called upon by upperclassmen in authority, to assist in all duties pertaining to college activities, such as social functions, Fiat Lux, work on Athletic field, Tennis courts, etc.
  - 5. None but Seniors shall carry canes.
- 6. Freshmen shall be required to hold open the chapel doors every morning until the student hody shall have passed out. This is to take effect after the first assembly. The student body shall pass out according to classes in the following order: Senfors, Juniors, Sophomores, Freshmen, Specials; the whole hody standing at once upon the dismissal of chapel.
- 7. All freshmen shall show due respect to University Faculty members and Seniors in such ways as touching the caps, giving

preference in entering and leaving buildings, on the Tennis Courts, etc. They shall also, when walking in company with an upper-classman, carry any books or parcels of said upper-classman.

8. Freshmen must carry matches for apperclassmen.

9. Freshmen must learn the Alma Mater before November 1.

10. Freshmen must attend all Varsity games held at Alfred, except as excused by the Student Senate.

11. Freshmen shall not wear white trousers.

12. All Freshmen shall keep off the grass on the campus west of Kanakadea.

# ARTICLE III-CLASS CONTESTS

 The only conditioned students allowed to take part in these contests are first year students. Upperclassmen sball not take part except as here-in-after stated.

2. The officials of all athletic class contests shall be upperclassmen in connection with the physical director.

Legitimate contests shall consist of procs. football, basketball, track, tennis, debates, and cross-country.

3. The Freshman class must challenge the Sophomore class in writing to the following contests: football, basketball, baseball, track, tennis, debates and cross-country.

4. If in any case the Freshmen fall so to challenge in these latter contests, it shall count a victory for the Sophomore class, unless by previous vote of both classes it is decided to omit such contests.

#### ARTICLE IV-PROCS

1. Procs shall be posted only during the week beginning on Monday following the opening of college and ending on Friday of the same week. They must be removed before 6:30 A. M. in order to count as a victory for the Freshmen.

2. No proc shall be posted after the first one is removed or defaced by the Freshmen or after the town clock has struck six.

3. The ringing of the chapel bell before or at 6 A. M. shall be the signal that the first proc has been removed. If the bell is rung by or for the Freshmen before any proc shall have been removed the contest shall be considered a victory for the Sophomores. At 6:30 the chapel bell shall be rung by a Senior member of the Student Senate as a signal that the contest is closed.

In the event of a false proc, the ringing of the bell will mean a cessation of activities for the day, only.

The chapel bell must at all times be accessible to both classes.

4. The procs, which shall not be smaller than one square foot, all of which must be visible and not more than ten in number, must be posted on the Campus as defined in Section 7 of Article II. They must be posted in the open; that is, they must not be concealed by any movable object, nor in any building, nor above eight feet from the ground, measurement to be made from the center of the proc.

5. No mechanical method of detention shall be permitted by either class.

- 6. A false proc and a real proc must not be posted on the same day nor shall real procs of more than one color be posted.
- 7. Procs shall be posted so that all printing is visible.

#### ARTICLE V

- 1. The Students' Association shall pay the Christian Associations one dollar per page for publishing in their annual Handbook the revised Constitution and By-Laws of the Students' Association.
- 2. Any person entitled to the major A may wear the regulation sweater.
- 3. The Senior Seal shall be worn by Seniors and Alumni only.
- 4. Dances for the benefit of the Athletic Association shall be managed by a person appointed by the Athletic Council.
- 5. All cases of violation of these Rules are to be referred to the Student Senate for settlement.

#### ARTICLE VI

Any student transacting any financial business for any student organization or in any activity involving students of Alfred College or School of Ceramics, shall be responsible to a faculty member chosen annually by the student body from among a number suggested by the faculty. Such responsibility will be interpreted to mean a strict accounting of methods and finance at whatever time the auditor chooses. Should any officer fail so to do, the auditor shall suggest an action to that body which placed bim in office.

The Senate shall enforce all the rules and publish all decisions in the Fiat Lux.

#### ARTICLE VIII

- 1. All officers and members of any student organization or activity of Alfred College or School of Ceramics shall be classified according to a definite system of credits, the number of credits being in proportion to the demand of each office upon the time of the student as well as upon the honor of the position.
- 2. For the system see the following diagram: No student may hold more units at any one time than will exceed his index. An index of 0.5 must be maintained in order to hold any office upon the campus.
- 3. Every two weeks the Registrar's Office shall furnish the Senate with a list of the indices of each student. A definite filing system shall be maintained by the Senate whose duty it shall be to notify those persons ineligible to hold office or participate in activities as stated in Art. 8, Sec. 2. If upon the expiration of two weeks the person has not cut down his units or raised his index in order to comply with Sec. 3, the Senate will intervene to adjust the situation.
- 4. In special cases the Student Senate has the power to allow a person to hold 0.2 units in excess of his index after satisfactory consent of this person's instructors.
- 5. This credit system of college honors and duties shall take effect at the beginning of the school year 1923-1924.

#### HONOR SYSTEM

### ARTICLE I

The student body of the College of Liberal Arts and the New York State School of Ceramics at Alfred University create an Honor System under which each student by his attendance pledges himself to be just; to be fair; to be honorable in all matters relative to or pertaining to scholarship in this University.

# ARTICLE II

Section I. The members of the Student Senate shall be a committee to represent the Student Body and deal with all cases involving violation of the Honor System.

# ARTICLE III

Section 1. Any one detecting a violation of this Honor System shall rise to his feet and give an immediate, impersonal.

public warning to that effect. In case of scheming violation of the Honor System, evidenced by papers on or about the person or by conspicuous opened books, such violation shall be subject to discipline under the Honor System. No more than two such warnings shall be given to any one student during an examination week. There will be but one public warning given in any one examination. The second violation will be followed by a report to the committee.

Section 2. The committee shall have the power to summon the accused persons and witnesses, and conduct a formal investiga-In case of conviction for the first tion. time, the committee shall recommend to the faculty that the term's mark for the subject or subjects in which the student has been convicted of violating the Honor System shall be cancelled and his or her name shall be posted in Kanakadea Hall and in the Library. In case of a second conviction, during the rest of the student's college career recommendation shall be made to the student by the committee of his separation from college and if such separation is not made, the committee shall then make the same recommendation to the faculty with a brief resume of the case.

# ARTICLE IV

Section 1. The trial of the accused shall be conducted as follows: Witnesses against the accused shall be examined first and their testimony taken in full. The accused shall be called separately and allowed to make his statement, presenting his de-

fense. All witnesses and the accused may be questioned by members of the committee. A decision shall be made, rendered according to the evidence.

Section 2. Six (6) out of seven (7) votes shall be necessary for conviction.

Section 3. All evidence possible shall be procured in every case and in no event shall a man be tried the second time for the same offense, except in the light of new and important evidence.

#### ARTICLE V

Section 1. Each student must, in order to make his or her examination or test valid, sign the following pledge: "I pledge my honor that I have neither given nor received aid in this examination," or the declaration: "I do so declare."

Section 2. Members of the faculty shall insist that the above said declaration or pledge be attached to every examination paper. Any examination paper lacking this pledge shall be considered void by the instructor in charge. The instructor must notify any student whose paper lacks the pledge and give the student the opportunity of signing the said pledge.

#### ARTICLE VI

Section 1. The Student Senate shall keep and preserve a record of all cases acted upon. In no case shall a member of the Student Senate make mention publicly or privately of any case brought before the committee except through action of the committee as a body.

#### ARTICLE VII

Section 1. Every student is honor bound to aid in enforcing this Constitution.

#### ARTICLE VIII

Section 1. This Constitution may be amended by a three-fourths (%) vote of those present at a student body meeting, or a revision may be authorized by a unanimous vote of said student hody, and the passage of the revised Constitution shall be secured by a three-fourths (%) vote of those present. Notice of this meeting shall be given at least one week previous to time of action, by its reading before the student body or by its publication in "Fiat Lux."

#### ARTICLE IX

Section 1. The committee shall make provision for interpreting the Honor System to the members of the Freshman Class during the first semester of each school year.

Section 2. Copies of this Constitution shall be posted in recitation rooms, on College bulletin boards, and in the Library.

Section 3. The Constitution shall be published three (3) times in the "Fiat Lux,"—the first number of the first semester, the last number before the final examinations of the first and second semesters.

# WOMEN'S STUDENT GOVERNMENT CONSTITUTION

#### ARTICLE I

This organization shall be called the Women's Student Government of Alfred University.

#### ARTICLE II.-MEMBERSHIP

Sec. 1. The membership of the Women's Student Government shall consist of all the women students in the college of Liberal Arts of Alfred University. Membership is not compulsory with those whose parents are residents of Alfred. All members shall have equal power of voting, except that the dormitory women (i.e. those residing in Abigail Allen Hall) may not vote on matters pertaining exclusively to non-dormitory women (i.e. those not residing in Abigail Allen Hall), and that non-dormitory women may not vote on matters pertaining exclusively to dornitory women.

Sec. 2. By the students whose parents are residents of Alfred, it shall be understood that their membership is not desired for social purposes only.

#### ARTICLE III.—PURPOSE-POWER

Sec. 1. The Women's Student Government shall have power to deal with all questions concerning the conduct of its members in their College life, insofar as these are not regulated by the Student Senate, and come within a list of regulations approved by a two-thirds vote of the Women's Student Government, and granted

by the Student Life Committee. It shall have power to inflict the penalties to enforce its decisions.

#### ARTICLE IV.—COUNCIL

- Sec. 1. The executive and indicial power of the Women's Student Government shall be vested in a council, composed of the president of the organization, the president of Abigail Allen Hall (Brick), and six other members, of whom one shall be an upperclass representative of Morgan Hall and an upperclass representative of the Pi Alpha Pi House.
- Sec. 2. The president of the Women's Student Government shall be a consulting member of the Student Senate.
- Sec. 3. A woman from the Freshman class shall be elected by the class as Freshman representative on the council, without the power of voting.
- Sec. 4. All business transacted in council meetings shall be kept secret unless otherwise ordered by a two-thirds vote of council.

# ARTICLE V.—LEGISLATIVE COM-MITTEES

- Sec. 1. The presidents of Abigail Allen II all, Morgan Hall and Pi Alpha Pi House and the three dormitory members shall constitute the legislative committee for said Halls.
- Sec. 2. The non-dormitory member of the council shall be chairman of a committee of three, members of which shall be elected by the non-dormitory women. This committee shall constitute the legislative committee for non-dormitory members.

Sec. 3. Initiation of new members shall be in October, and regulated by the Council.

#### ARTICLE VI.-TIME OF ELECTIONS

- Sec. 1. The election of the council shall take place the last week in April. At least three weeks prior to the election of the council, the president shall appoint a nominating committee of five members, two of whom shall have been members of the coun-The nominating committee shall confer with the president to nominate the members of the council. These nominations shall be posted on the College Bulletin Board at least two weeks prior to the election. After the election of members of the council in April, the new council shall hold joint meetings with the former council until the end of the school year, under the chairmanship of the former president. Both councils shall co-operate and co-ordinate in all the duties of the council, and the new president and council shall assume their duties in September.
- Sec. 2. The representative from the Freshman class shall be elected by the class every two months. No Freshman shall be eligible for representative for more than two months in the year.
- Sec. 3. The committee appointed by the president to nominate members of council shall also act as a committee for the revision of rules.

# ARTICLE VII.-DUTIES OF OFFICERS

Sec. 1. The president shall be the executive officer of the organization, and shall call together and preside over all meetings of the organization and council.

Sec. 2. The duties of the vice president shall be to assume the duties of the president in the absence, or at the request of the president.

Sec. 3. The duties of the secretary shall be to keep the minutes of all meetings of the organization.

Sec. 4. The duties of the treasurer shall be to act as custodian of all funds of the organization, paying bills only by vote of council, and on receipt of an order signed by the President and Secretary of the organization.

Sec. 5. The duties of the non-dormitory legislative committee shall be to meet at least once a month to enforce rules pertaining to non-dormitory women. The duties of the chairman shall be to call meetings of the non-dormitory legislative committee, and to call and preside over such meetings of non-dormitory women as are necessary for the administration of non-dormitory business. The president of the Women's Student Government has power to call special meetings of this committee whenever she deems it necessary.

#### ARTICLE VIII.-ELIGIBILITY

Sec. 1. The President of the Women's Student Government shall be a Senior, and she shall have preferably served on the council, either as a representative or as a member prior to her Senior year

Sec. 2. Three unexcused absences from Council meetings by a member shall disqualify her for office. Written excuses shall be presented to the council for acceptance or rejection at the first meeting following the member's absence.

Sec. 3. Any member is liable to impeachment for misconduct in office by a two-thirds vote of the Council and may be removed from office by a two-thirds vote of the entire Women's Student Government.

#### ARTICLE IX

Sec. 1. A quorum of the Women's Student Government shall consist of at least two-thirds of its members.

#### ARTICLE X

Sec. 1. Six members of the council shall constitute a quorum, and no action shall be taken by the council upon the agreement of five voting members.

#### ARTICLE XI

Sec. 1. There shall be a business meeting of the organization once a month. Business meetings shall be called at 6:45 P. M. Attendance at husiness meetings shall be compulsory.

Sec. 2. The council shall meet regularly every week for discussion of matters and for the transaction of such business as is necessary.

# ARTICLE XII

Sec. 1. Each member of the organization shall be supplied with a copy of the Constitution and Regulations of the Women's Student Government at the beginning of each College year. The Constitution and the Regulations shall be read by the president to the freshman class at its first meeting.

# ARTICLE XIII

Sec. 1. This Constitution may be amended by a two-thirds vote (of a quorum) of the organization.

# REGULATIONS

#### ARTICLE 4

Sec. 1. The Women's Student Government heartily believes that normal comradeship between young men and young women, in mutual respect and reverence, in fine self-direction and self-control are essential to the co-operation of social life and activities with the claims of health and scholarship.

The following regulations are an attempt to adapt the members of this organization to the special conditions of the college community. This organization expects its members to be guided by the underlying principles of wholesome social relationships in all situations whether covered by these definite statements or not. Disregard of these principles or violations of the regulations will be considered sufficient grounds for imposing penalties.

## ARTICLE II.-CLOSING HOURS

Sec. 1. Seniors shall be at their places of residence by ten P. M. except on Friday, Saturday and Sunday nights when the hour shall be ten-thirty P. M.

Sec. 2. Juniors shall be at their places of residence by nine-thirty P. M. except Friday, Saturday and Sunday nights when the hour shall be ten-thirty P. M.

Sec. 3. Sophomores shall be at their places of residence by nine-thirty P. M. except Friday and Sanday nights when the hour shall be 10:00 P. M., and Saturday night when the hour shall be 10:30 P. M.

Sec. 4. Freshmen shall be at their places of residence by nine P. M., except Friday and Sunday nights when the bour

shall be 10:00 P. M., and Saturday night when the hour shall be 10:30 P. M. Beginning May 1, closing hours for Freshmen shall be 9:30 instead of 9:00 P. M.

Sec. 5. All women not attending functions on the College Calendar shall observe regular closing hours.

#### ARTICLE III

Sec. 1. Special permission from the Council must be obtained for all in town and all out-of-town parties and entertainments lasting later than the closing hours specified in Article II, sections 1, 2, 3, 4. although supervised by the Student Life Committee, or granted by the Student Senate, but not on the College Calendar.

Sec. 2. Application for special permission to attend parties or entertainments not on the College Calendar and lasting later than the aforesaid closing hours must be made to the Council as far in advance as possible of the occasion in order to give the Council opportunity to grant or reject the permission, as is advisable.

Sec. 3. Application for special permission shall be made in the form of a petition signed by the applicant, delivered to the president of the organization. In order to grant permission, the petition must be signed by the president of the organization and one other upperclass representative on the Council.

Sec. 4. Women attending functions for which special permission has been granted shall be at their places of residence at 12:00 P. M.

Sec. 5. Closing hours for all women

shall be 10-20 P. M. during vacation except when special permission has been granted by some authorized member of the Council.

Sec. 6. Women shall be allowed to go to the restaurant after functions on College Calendar which fall on Thursday or Saturday nights, and nights of the Fraternities Club Entertainments.

#### ARTICLE IV

Sec. 1. Entertaining shall be regulated as follows: Members of the organization may entertain on Friday and Sunday evenings and on Saturday and Sunday afternoons. Young men will call at other times only as escorts.

Sec. 2. In case Fraternity Banquets fall on Saturday nights, permission may be granted to entertain inside to those who do not attend the Banquet. Regular closing hours shall be observed.

#### ARTICLE V

Sec. 1. Groups of not over eight people attending evening parties, picnics or automobile rides, not lasting later than the closing bours specified in Article II, Sections 1, 2, 3, and 4, may be chaperoned by a Senior woman, provision for such chaperonage having been made with the council or president of the organization. Parties of more than eight people, and lasting later than closing hours shall be referred to the regulations on chaperonage of the Student Life Committee.

Sec. 2. "Not lasting after closing hours" in Sec. 1 of this article shall be interpreted to mean that women shall be at their places of residence at the closing hours specified in Article II.

Sec. 3. Any woman, other than a Senior, going on picnics not lasting later than eight o'clock must sign her name in a book provided for that purpose and must check off in person her name, stating time of return.

Sec. 4. A Freshman woman, with an escort, must be chaperoned by an upperclass woman until eight o'clock on picnics, hikes, automobile rides or on any occasion taking her outside of the town limits and after eight o'clock must be accompanied by a Senior woman. This ruling applies to all Freshmen until Christmas vacation.

#### ARTICLE VI

Sec. 1. Any member upon leaving town shall leave, with th person in authority at the place at which she is rooming, information as to where she is going, and her address while out of town.

#### ARTICLE VII

Sec. 1. Each member shall be assessed \$1.00 a year. This amount should be paid to the treasurer during the last week of November.

Sec. 2. Provision shall be made to send the President of Women's Student Government, and a Junior representative to the annual Inter-collegiate Student Government Convention.

#### ARTICLE VIII

Sec. 1. Each member of the Women's Student Government is honor bound to observe and to co-operate in enforcing this system of government.

# CONSTITUTION OF THE ATHLETIC ASSOCIATION

#### ARTICLE I-NAME

Section 1. The name of this Association is the Alfred University Athletic Association.

#### ARTICLE II—OBJECT

Section 1. The object of the association is to train the physical part of men and women through games, contests and athletics.

Section 2. To promote between Interscholastic and Intercollegiate Institutions, Athletic Contests.

Section 3. To raise funds for the promotion of such enterprises.

Section 4. To purchase, lease, hold or take by deed such hulidings and other real estate as may be found consistent in the transaction of such purposes. To equip and improve them in such a way as to make them best fitted to maintain such a business. The association may run such business enterprises that may indirectly or directly raise funds for such maintenance.

### ARTICLE III-OFFICERS

Section 1. The officers of the Athletic Association of Alfred University shall he President, Vice President and Secretary, elected by the student athletic council from among the councilors, and shall hold the same offices in the Association as in the council.

Section 2. To give centralized direction the Athletic Council shall be composed of twelve representatives called councilors, elected by ballot, from the students of College and State School of Agriculture, one a man and one a woman from each of the upper classes, and two underclassmen from each of college and State School of Agriculture. Two weeks before the close of the State School of Agriculture each of the two schools shall elect its next year's councilors, two students each, from the upper classes of College and one from the Junior class and one from the Freshman class in the Agricultural School. When the acting president of the council shall have received the names of those elected. he shall call a meeting of the six members and they shall elect their President. Vice President and Secretary, and organize the council for the ensuing year. underclass representatives shall be elected at the earliest time in the fall practicable, and act during the ensuing year. The term of office of the council shall begin at the close of the summer session. The first meeting is at the call of the President, and subsequently weekly meetings shall be arranged. The chairman of the Faculty Athletic Committee, the Director of Athletics, the coach and the Graduate or faculty manager are non-voting members of the council, sitting in an advisory capac-The business managers of the various itv. departments and captains of the various teams shall attend council meetings at the summons of the president.

Section 3. A member of the University Faculty shall be appointed by the council to have charge of the Injury Fund, his term of office to be three years.

Two assistant managers shall also be appointed by the council, their terms of office to be one year.

Section 4. The graduate or faculty manager shall be appointed by the Alumni Advisory Board on Athletics from a list of three names to be submitted annually, or whenever a vacancy exists, by a majority vote of the members of the Athletic Association and he shall hold office during the approval of the Advisory Board. In case no names are presented or those presented are unsatisfactory to the Board, an appointment may be made by the unanimous vote of the Advisory Board. The graduate or faculty manager shall be bonded to the Association to the extent of \$500. graduate or faculty manager shall receive such remunerations for his services and exnenses as may be approved by the advisory board, and such remuneration shall be paid from any funds received by the advisory board for the promotion of athletics. The graduate or faculty manager shall also inventory all property and make account of wear and tear on equipment. The department equipment shall be deposited with him and surrendered to the departmental manager on a regular account basis, to be held each seasonable year.

The Alumni Advisory Board on Athletics shall be responsible for all debts incurred by the association.

The Graduate or Faculty Manager shall be a member of the association and shall be subject to the articles of the constitution. He shall submit at the end of each term a complete financial report to the athletic association and to the Alumni Advisory Board on athletics.

The student manager of the different sports shall be assistant manager and shall act for the graduate or faculty manager either upon his request or during his absence.

Section 5. The council shall appoint a trainer and three assistant trainers from among the pre-medical students, their terms of office to be one year. They shall be directly under the supervision of the Coach.

#### ARTICLE IV-DUTIES OF OFFICIALS

Section 1. The President shall preside at meetings of the Association and of the Council. He can call meetings of the council or of the Association, provided they be given reasonable publicity. Four councillors or ten Association members can call a meeting of their respective bodies by signed and posted notices.

Section 2. The Vice President shall assume the duties of President during his absence. It is advisable that either President or Vice President be a college or ceramic school man due to longer sessions.

Section 3. The Secretary shall keep the records of the Association and of the Council.

Section 4. The University faculty member in charge of the injury fund shall be responsible for all money raised for such cause. Upon the consent of the council he shall make such payments as are deemed necessary.

The duties of the assistant student

managers shall be to raise money for this purpose.

Section 5. Any member of the council having three consecutive unexcused absences shall be suspended from the council.

Section 6. The Athletic Council is the executive board of this Association. It shall direct the policies, grant the privileges and the franchises of this Association, and determine the manner of granting the same, and under due provocation evoke any privilege granted.

Section 7. The council shall choose a student manager and three assistant student managers each from College and Agricultural School for each sport at the close of the season for the ensuing year or to fill vacancies. Manager for the following year shall be chosen from among the assistant managers.

Section 8. All students who have participated in any one intercollegiate game during the season shall meet at the call of the retiring captain and elect the captain for the ensing year.

Section 9. Any student of Alfred University paying the dues of the Association is eligible to vote in matters of business and shall be entitled to admission to the games under its auspices; and under reasonable restrictions imposed by this Association, can become a participant in its games, and eligible to wear its honors and insignia.

Section 10. The President, Vice President and Secretary of the Association shall

meet with the Alumni board and determine the respective parts in a future program.

Section 11. The chairman of the faculty committee on Athletics shall be a member of the Alumni board.

# ARTICLE V .- ATHLETIC ELIGIBILITY

Section 1. A candidate for a position on a team shall present bimself to the chair-man of the Athletic Committee and sign the following declaration:

# Amateur Standing Card

I herein assert that I never played athletics professionally. I herein further assert that while in College, I will enter into no athletic contests other than those that appear on the athletic calendar of Alfred University, or such special cases as may be decided on their merits by the Athletic Committee.

Section 2. Any student to be eligible to a team of this Association must be a bonafide registered student, carrying a schedule during the term of at least ten hours' work a week in college; or 15 hours per week, during the term in the State School of Agriculture, and maintaining it at satisfactory grades.

Section 3. At the beginning of each season the graduate manager shall file with each instructor a list of names from which the personnel of the team shall be chosen. Names shall be added to or taken from this list only after the graduate manager has notified each instructor of the change.

Section 4. If any student playing on an athletic team shall fall below a passing

grade, the instructor shall notify the chairman of the athletic committee of the same before the beginning of the following week. In case the student shall be reported in two or more subjects he shall not participate in contest until the instructor any athletic shall have notified the chairman of the committee that the student has attained a higher grade. When the student is deficient in only one subject, he may be allowed four weeks from the time that he is reported to bring his work up to the passing grade before being debarred from the Instructors shall notify the comteam. mittee of the removal of such conditions as soon as possible.

Sec. 5. The second team shall consist of only those men who have regularly participated in practice against the varsity. The second team shall be under the jurisdiction of the coach, and no group of men other than the above stated shall represent the University in any form of athletics.

Sec. 6. The coach shall have complete jurisdiction of the team in all matters of conduct. He shall be required to suspend from the team for a time commensurate with the offense, any student guilty of immoral, ungentlemanly or unsportsmanlike conduct.

Sec. 7. No more than one game of basketball, baseball or football shall be played in any one week, by any one of the teams making schedule, except when the team can profitably play a series of games on any one trip away from home. Extra games may be played on days when classes are not in session. (See rules 3 and 4). Sec. 8. The Faculty permits the following teams to make a schedule: football team, women's basketball team, men's basketball team, track team, tennis team, cross-country team and wrestling team; also the corresponding second teams, and freshmen teams.

Sec. 9. Second teams shall not play out of town games.

Sec. 10. Freshmen shall be allowed to play out-of-town games, with the consent of the athletic council.

# ARTICLE VI.—BY-LAWS OF BOARD GOV-ERNING INSIGNIA AND HONORS

Section 1. The major sports are Football, Basketball, Baseball, and Track. The minor sports are Tennis and Wrestling,

Section 2. Every athlete who is entitled to a first team insignia in either major or minor sports, shall receive a certificate designating the authority for wearing the letter. This certificate shall be signed by the chairman of the athletic committee (faculty), the coach and the president of the athletic council.

Section 3. The insignias for major sports are block A's, the football A to be 9" x 9", the basketball, baseball and track A's to be 9" x 7". All second team insignia for major sports are three inch block A's within a triangle.

Any athlete participating in intercollegiate sports must play in one-half the playing time each season to win the major insignla except on the approval of the Athletic Council after recommendations by the Coach. The managers of the different de-

partments shall receive the major insignia of that department with an M attached.

Any person breaking a Track record shall receive a track A.

Any man winning a first place, or its equivalent in points in an intercollegiate track meet shall receive a track A.

Any giri who shall win a tennis tournament with at least ten original entries in singles or six entries in doubles shall receive a tennis A.

Any athlete receiving a second team insignia for four consecutive years in the same sport, shall be entitled to wear the first team insignia of that sport.

Any Agricultural School men receiving second team insignia for three consecutive years shall be entitled to wear first team insignia of that sport.

Any athlete participating in an intercollegiate tennis tournament shall receive a tennis A.

Any athlete winning at least 1 point in 'an intercollegiate track meet or on recommendation of the Coach shall receive a second team insignia.

The student trainer shall receive a 9" block A with a T attached.

Section 4. Class numerals are 3" numerals awarded for participation in at least half of three different interclass sports with the exception of track. The person must win at least one point in track to have it count toward his or her numerals.

Section 5. Amendments to this constitution can be made by a two-thirds vote after having been published in the Fiat Lux.

# CONSTITUTION OF THE VARSITY . "A" CLUB OF ALFRED UNIVERSITY

#### ARTICLE I-OBJECT

The object of this club is to promote interest among the Alumni in University athletics; to assist worthy students desirous of entering the University; to foster all worthy movements in the interest of Alfred especially those which will assist in clean, vigorous athletics.

#### ARTICLE II-NAME

The name of this organization shall be the Varsity "A" club of Alfred University.

# ARTICLE III-ELIGIBILITY RULES

Sec. 1. Any person who has been granted a varsity "A" in any branch of athletics, recognized by the Athletic Association, shall be eligible for membership in the club by handing to the secretary a written application and by a two-thirds vote of those present at a regular meeting, and by payment of the semi-annual dues.

Sec. 2. Any persons who have not won a varsity "A" but are especially interested in the athletic welfare of the University may be elected to honorary membership in the same manner by application to the secretary.

#### ARTICLE IV-OFFICERS

- Sec. 1. The officers shall be President, Vice-President, Secretary, Treasurer, and Historian. The President shall be a member of the upper classes.
- Sec. 2. All officers shall be elected at the regular meeting held the second week in May, and their term shall be for the ensuing year.
- Sec. 3. All elections shall be by ballot.
- Sec. 4. In addition to the elected officers, there shall be two standing committees, of five members each, appointed by the President, including the chairman as provided for in Sec. 2-3 in Article V, an entertainment committee and a publicity committee. The entertainment committee shall attend to the welfare of all visiting teams and to arrange all social activities. The publicity committee shall correspond with the Alumni and prospective athletic material.

#### ARTICLE V-DUTIES OF OFFICERS

- Sec. 1. The President shall perform the duties of presiding officer and chairman of the club. He shall appoint all standing committees and all other committees authorized by the club.
- Sec. 2. The duty of the Vice-President shall be to act as chairman of a meeting in the absence of the President, and as permanent chairman of the entertainment committee.

- Sec. 3. The secretary shall keep a record of each meeting, and shall read the minutes when so requested by the chairmen. He shall read and file all resolutions and papers which may come before the club, and allow none to go from his custody without due authority. He shall act as permanent chairman of the publicity committee and shall be third presiding officer.
- Sec. 4. The treasurer shall collect all dues; shall keep the accounts of the club and make all disbursements subject to the control of the club. He shall render the statement of accounts at each annual meeting. His accounts shall be andited annually by three members authorized by the club.
- Sec. 5. The historian shall keep a scrap book record and pictures and material relating to athletics of the University.

#### ARTICLE VI-MEETINGS

- Sec. 1. The regular annual meeting of the club shall be held the second week in May, to elect officers for the coming year. The treasurer and auditory committee shall give complete reports.
- Sec. 2. Regular meetings of the club shall be held once a month.
- Sec. 3. Any member missing three consecutive regular meetings shall be automatically suspended.

#### ARTICLE VII-ORDER OF MEETINGS

Sec. 1. At all meetings the following shall be the order of business:

- 1. Roll call
- 2. Reading of minutes
- 3. Report of treasurer
- 4. Report of standing committees
- 5. Report of special committees
- 6. Unfinished business
- 7. New business
- 8. Election of new members
- 9. Election of new officers
- 10. Adjournment.

#### ARTICLE VIII-INSIGNIA

Sec. 1. The club insignia shall be a distinctive emblem which all members are entitled to wear upon the payment of their initiation fee.

#### · ARTICLE IX—QUORUM

Sec. 1. A quorum shall consist of one-half of the membership of the club, and at least one presiding officer present.

#### ARTICLE X-AMENDMENTS

Sec. 1. This constitution and by-laws may be amended at any regular meeting of the club by the affirmative vote of two-thirds of the members present.

#### Kanakadea

The Kanakadea is the Alfred Year Book, published annually by the Junior class. The Board of Editors is chosen from the Juniors with one representative from each of the other classes.

#### Footlight Club

The Footlight Cluh is an organization to promote the best in dramatics. Its members are elected from those who show the most ability for acting, and a try-out play is held the first part of each college year. At least once every year some suitable play is selected and given by the club.

#### Chorus

The University Chorus, consisting of about a bundred voices, gives an opportunity to all who wish to improve themselves along musical lines. Each year one of more concerts are given in which much valuable experience is gained by the students,

#### Ceramic Society

The Ceramic Society is a student branch of the American Ceramic Society. It consists of all the upperclassmen and the faculty of the New York School of Ceramics. The society meets regularly and discusses Ceramic problems and other items for self improvement.

#### Ceramic Guild

Organized by the Art Department as a means of advertising the school by acquainting the people with a pleasing and creditable grade of pottery and as a means for the disposal of student work the Ceramic Guild gives regular exhibitions which have been very successful in the past.

#### General Athletics

Athletics are the spice of college life. Without them there is little to keep up college spirit at Alfred or any other College. Athletics do not pay financially, yet for the good of the College they must be kept up by the students. Successful teams are the best physical training department a college can have.

It is the duty of all to support athletics and of every one who can, to get on the field and do his part to make the season successful. Football, baseball, basketball, tennis, wrestling and track are played here. Nearly everyone is capable of taking up at least one of the above forms of exercise and should show his spirit by trying out for the teams.

Under the new arrangement, athletics are controlled in the college by the Athletic Council consisting of twelve councillors, eight from the college and four from Ag School. A committee of four faculty members acts in an advisory capacity to the council. The Council formulates the general policy to be pursued, while the execution of the plans is effected by the graduate manager, who has broad powers. Under the graduate manager are managers and assistants, elected by the Council for work in specified sports.

Financial support is secured through membership, payment of dues and receipts from games, although the amount from all sources is not sufficient to prevent hampering our athletics. Every college student becomes a member of the association upon payment of his tuition bill, which includes an athletic tax of \$10.00 a year, making all bona fide members with all rights to hold office under the association's supervision. By vote of its student body, Agricultural School assesses itself.

#### Football

is the college game. It is possible for a small college with the proper spirit to get out a winning football team. This has been proven at Alfred. With the students all pulling together and each one doing his

share it will be possible for Alfred to have more winning teams this year. Come out freshmen and try for the team.

#### Basketball

This sport is becoming more successful each year. The score of last year proves this. Every man who has played basketball is urged to try out for a place on Alfred's five.

#### Tennis

There is much interest in tennis in recent years. Three courts are in excellent condition and more are planned for. It is being looked on with favor as a varsity game. Every year a tournament is held which creates great interest.

#### Interclass Track Meet

Interclass day gives every one an opportunity to show his class spirit and to win his class numerals if he failed to do so by playing on the class teams. Great interest is shown when all the classes meet and compete with each other for supremacy on the track and field.

#### Intercollegiate Track

Track has achieved a new place in College athletics during the past three years. Alfred is now putting out a team which is capable of competing with the best in this sport.

This sport, though new in Alfreé last year, was most successful. An exceptionally good schedule has been arranged for next year. If you are fleet-footed this is your chance.

#### Interscholastic Day

For the last fifteen years, Alfred has held an interscholastic track meet at which high schools from central and western New York and Pennsylvania have been represented. Greater interest is shown in this event each year and large crowds come a great distance to see the meet. All the principal field and track contests are held and also two prize speaking contests—one for men and one for women.

#### The Varsity "A" Club

This Club is composed of men who have earned their major or minor "A's." It also includes the managers of the different clubs. Each man is elected to the Club by a majority vote. The purpose of the Club is to promote a greater athletic interest and to encourage high school students to attend Alfred.

#### The English Club

Primarily organized with the purpose of studying contemporary literature the English club serves as a means of developing critical and appreciative reading of literature. Its informal discussions make its meetings entertaining and gives an opportunity for self expression.

#### The Mathematical Society

A very popular society aiming to enjoy the entertaining and recreational sides of mathematics as well as some of its serious problems. It now also includes a chess club where active and powerful opposition can be met by anyone desiring it.

#### FIAT LUX

The "Fiat Lux" is the University paper, the medium through which the news, announcements, strivings and attainments of the students are presented.

The life of and the interest in the paper depends for the most part on its news value, which is a function of hearty student co-operation. Report to the editors all activities of general interest, hand in suggestions for editorials or articles; if a bit of news from an alumnus is received, make it possible for the subscribing alumni to know of it. "Fiat Lux" can only live up to its name and give light to all concerning Alfred through the interest and help of all.
